Refund Policy

Due to the cost of customizing our individualized Study Programs, there is no refund or cancellation of any of our programs. However, if a student has an emergency which makes it impossible for him or her to complete their program, and he or she wants to appeal this policy the student must submit an application in person to Hello WorldSM Language Center. If the cancellation is approved by a Hello WorldSM Language Center Director, tuition will be funded at the following rates:

For Pre-payments:

- Registration, Shipping and Material Fees are not refundable.
- 75% Before the first class
- 50% If there are 20% or fewer of the sessions completed, if the teacher has been assigned or failure to enter.
- 25% If there are 40% or fewer of the sessions completed.
- There is no refund after 40% of the sessions elapsed.

For Monthly Payments:

- Registration, Shipping and Material Fees are not refundable.
- Students will be billed at the highest monthly rate for the courses offered, and students must pay the difference between that and whatever discounted amount plus one month of tuition for all months in which they took classes (i.e. students who took 5 1/2 months will pay for 7 months, students who took 2 1/2 now, will pay for 4 months, etc).

For Overseas Applications:

- Registration, Shipping and Material Fees are not refundable.
- The refund will be the amount paid by the applicant minus (–) the Registration Shipping and Material fees, within 30 days after the date that the student contact school with proof of the Visa Denial. All refunds will be made in US Dollars by money order or check. Any fees for money orders transfer fees, etc. will be paid by the student.

Tutorials:

If a student has an emergency which makes it impossible for them to complete their program, and they wish to cancel the program, student must submit an application in person to Hello WorldSM Language Center. If the cancellation is approved by a Hello WorldSM Director, tuition will be refunded at the following rate:

For Pre-payments:

- 75% Before the first class.
- 50% If there are 20% or less of the sessions completed, if teacher has been assigned, or failure to enter.
- 25% If there are 40% or less of the sessions completed.
- There is no refund after 40% of the sessions have elapsed.

For Tuition Payment Plan:

- Tuition Payment Plan prices are based upon a 3 month or 6 month contract (1 or 2 semesters).
- Cancellation of the contract prior to meeting the minimum 3 month contracted obligation will result in the elapsed sessions being re-calculated at a per-hour rate of \$50.00 per hour.
- The student accepts responsibility for payments of any re-calculated tuition that exceeds payments prior to the cancellation of the tutorial.

In the event that Hello WorldSM chooses not to meet this obligation of any reason to teach a student, the student will be refunded on a pro-rated basis of the unused tutorial session. (For example: If the student was taught for ten sessions remain, the student will receive a refund of 50%).

Traditional Classroom Tuition:

- 75% Before the start of the first class. Non-refundable after the first class.

Cancellations: Students in Tutorial Programs who wish to cancel a session must give at least 24 hours notice to Hello WorldSM, and must make arrangements for a make-up session within a one week period of the date session was supposed to occur. If the 24 hours notice is not received, and make-up session is not scheduled within one week of original session, that session will be recorded as having occurred, and will not be able to be made up. Classroom classes cannot be cancelled or made-up. Hello WorldSM will attempt to give at least 24 hours notice if a Hello WorldSM teacher cannot attend a session. Sessions that Hello WorldSM must cancel will be automatically made up at the end of the tutorial period unless other arrangements have been made. Hello WorldSM also reserves the right to have a "substitute" instructor teach any class an assigned instructor cannot attend.

Automatic Renewal: Students may automatically renew a Program in writing or verbally. If a student requests an additional semester, it will automatically continue as per this Agreement, and student will be required to comply with the same duration, terms and conditions as in the original semester and of this arrangement.
